Thai FDA Notification: Criteria regarding production, import and storage of cosmetic

Topics required for quality standard for cosmetic production are:

- 1) Quality manual: To consider overall control and monitoring, organization and responsibility.
- 2) Personnel: Adequate number of personnel having knowledge, experience, skill and capabilities.
- 3) Premises: The premises should be suitably located, designed, constructed and maintained.
- 4) Production equipment: Designed and located to suit the production, clean and proper storage. 5) Sanitation and hygiene: Sanitation and hygiene should be practiced to avoid contamination.
- 6) Production: Good practice assigned to material, production process, packing and storage.
- 7) Quality control: An essential part of GMP for assurance of cosmetic products of consistent quality.
- 8) Documentation: The documentation system should include the complete history of each batch.
- 9) Storage: Sufficient capacity to allow orderly storage of the various categories of materials and products.
- 10) Complant: A person responsible and deciding the measures to be taken should be designated.
- 11) Internal Audit: An Internal audit may be conducted by outside or independent specialists or team designed by management to assessment quality system.
- 12) Contract manufacturing and analysis: All aspects of contracted work should be specified to obtain a guality product conforming to the agreed standards.
- 13) Product recalls: There should be a system of recall from the market of products known or suspected to be defective.
